1. Sponsor.

2. Eligibility.

The AMD Siggraph Tech Talk Session #1 (the "Promotion") is open only to persons who are 18 or older, who completely fill out the Promotion eligibility and entry form ("Participants"). Employees of Advanced Micro Devices, Inc.
